Create a list of historic buildings that the City wants to identify with a plaque and add to an electronic walking tour. **Vizcarra** mentioned the Whitman. **Hobson and Ryan** will co-lead the project to identify buildings for the plaque historic tour. **Anglesey** will assist by pinning the buildings on a GIS map using the City HUB.
