AN ORDINANCE OF THE CITY OF POCATELLO, A MUNICIPAL CORPORATION OF IDAHO, REPEALING CHAPTER 5.30 "CHILDREN GROUP TREATMENT CENTERS" OF THE REVISED AND COMPILED ORDINANCES OF THE CITY OF POCATELLO, 1983, AND PROVIDING THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL, AND PUBLICATION ACCORDING TO LAW.

WHEREAS, Pocatello Municipal Code Chapter 5.30 "Children Group Treatment Centers" was established by the City Council upon passage of City of Pocatello Ordinance No. 2811 on April 19, 2007 and amended thereafter; and

WHEREAS, the City Licensing Enforcement Officer recently reviewed said chapter and identified it as an area requiring updating; and

WHEREAS, this particular code was established to regulate children group treatment centers that were not being well regulated by the Department of Health and Welfare, at the time; and

WHEREAS, this type of licensing has not been utilized since prior to 2011 and is now regulated by state code; and

WHEREAS, the City Council has determined that the repeal of said chapter is in the best interest of the citizens of the City of Pocatello.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF POCATELLO AS FOLLOWS:

Section 1: That Chapter 5.30 "Children Group Treatment Centers" of the Revised and Compiled Ordinances of the City of Pocatello, 1983, is hereby repealed in its entirety.

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication according to law.

AN ORDINANCE OF THE CITY OF POCATELLO, A MUNICIPAL CORPORATION OF IDAHO, REVISING TITLE 15, "BUILDINGS AND CONSTRUCTION" OF THE POCATELLO MUNICIPAL CODE, MORE PARTICULARLY BY REVISING SECTION 15.02.010 "CODE ADOPTION"; AND PROVIDING THAT ALL OTHER SECTIONS OF CHAPTER 15 NOT HEREIN AMENDED SHALL REMAIN IN FULL FORCE AND EFFECT; PROVIDING THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL, AND PUBLICATION ACCORDING TO LAW.

WHEREAS, following the 2025 legislative session, the State of Idaho has implemented adoption of the 2023 National Electrical Code, NFPA 70; and

WHEREAS, the Building Official reviewed the latest code updates and recommended that the City of Pocatello adopt the updated edition of the electrical code previously adopted by the City; and

WHEREAS, the City Council determined that this change is in the best interest of the citizens of the City of Pocatello.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF POCATELLO AS FOLLOWS:

<u>Section 1</u>: That Section 15.02.010 "Code Adoption", of the Revised and Compiled Ordinances of the City of Pocatello, 1983, be hereby amended to read as follows:

15.02.010: CODE ADOPTION:

A. Uniform, International, And National Codes:

- National Electrical Code, <u>20172023</u> edition, and appendix H, and additions and amendments to the National Electrical Code, <u>20172023</u> edition, as identified in the current IDAPA Standards, 07.01.06.

<u>Section 2</u>: That all other provisions of Chapter 15.02.010 shall remain in full force and effect.<u>Sections 3</u>: That this Ordinance shall be in full force and effect from and after its

passage, approval, and publication according to law.

AN ORDINANCE OF THE CITY OF POCATELLO, A MUNICIPAL CORPORATION OF IDAHO, AMENDING CHAPTER 17.04 "OVERLAY AREAS" OF THE REVISED AND COMPILED ORDINANCES OF THE CITY OF POCATELLO, 1983; MORE PARTICULARLY BY AMENDING CHAPTER 17.04.170 "SENSITIVE LANDS STANDARDS" TO PROVIDE CLARITY AND IMPROVE THE FUNCTION OF THE TITLE; AND PROVIDING THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL, AND PUBLICATION ACCORDING TO LAW.

WHEREAS, City Planning and Development Services staff initiated a review of Pocatello Municipal Code Chapter 17.04.170 "Sensitive Lands Standards;" and

WHEREAS, City Planning and Development Services staff identified an area requiring updating; and

WHEREAS, the City Council has determined that the proposed amendment of Chapter 17.04 "Overlay Areas" is consistent with the existing codes governing zoning, is consistent with the City's Comprehensive Plan, and is in the best interest of the citizens of the City of Pocatello.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF POCATELLO AS FOLLOWS:

<u>Section 1</u>: That Chapter 17.04.170 "Sensitive Lands Standards" of the Revised and Compiled Ordinances of the City of Pocatello, 1983, shall be amended to read as follows:

17.04.170: SENSITIVE LANDS STANDARDS:

- B. Applicability: The provisions of this section shall be applied to any property or parcels containing sensitive lands as identified herein and/or as depicted in the Comprehensive Plan. These provisions shall apply regardless of whether or not a building permit, development permit, land division, or other authorization is required. These provisions do not provide any exemption from any state or federal regulations that may apply. The City of Pocatello has designated the following as sensitive lands:
 - 1. Wildlife habitat protection areas. <u>Designated areas east of the Portneuf River, below</u> elevation 4,700', may be exempted from density and clustering standards of this section;

AN ORDINANCE OF THE CITY OF POCATELLO, A MUNICIPAL CORPORATION OF IDAHO, APPROPRIATING \$161,827,149, FOR THE 2026 FISCAL YEAR TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE CITY; PROVIDING FOR THE OBJECTS AND PURPOSES FOR WHICH SUCH APPROPRIATIONS ARE MADE AND THE AMOUNT APPROPRIATED FOR EACH OBJECT OR PURPOSE; LEVYING AD VALOREM TAXES IN THE AMOUNT OF \$35,865,971 FOR THE FISCAL YEAR BEGINNING THE FIRST DAY OF OCTOBER, 2025, AND ENDING THE THIRTIETH DAY OF SEPTEMBER, 2026, UPON ALL OF THE TAXABLE PROPERTY WITHIN THE CITY OF POCATELLO TO PROVIDE REVENUE TO PAY CURRENT GENERAL, STREET, LIABILITY INSURANCE, RECREATION. CEMETERY, AIRPORT, **PUBLIC** LIBRARY, IMPROVEMENTS EXPENSES AND TO PAY INTEREST AND PRINCIPAL ON GENERAL OBLIGATION BONDS OF THE CITY OF POCATELLO; PROVIDING THAT A CERTIFIED COPY OF THIS ORDINANCE SHALL BE FILED WITH THE COUNTY COMMISSIONERS OF BANNOCK COUNTY, IDAHO, POWER COUNTY, IDAHO AND WITH THE SECRETARY OF STATE OF THE STATE OF IDAHO; PROVIDING FOR THIS ORDINANCE TO TAKE EFFECT UPON ITS PASSAGE, APPROVAL, AND PUBLICATION ACCORDING TOLAW.

WHEREAS, the City has provided proper notice and held a public hearing on August 7, 2025, regarding the proposed budget for Fiscal Year 2026; and

WHEREAS, the City Council has reviewed the proposed budget and determined that the expenditures are necessary.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF POCATELLO AS FOLLOWS:

Section 1: That the appropriations and the amount appropriated for the fiscal year beginning October 1, 2025, through September 30, 2026, be set as follows for the objects and purposes as herein specified:

Section 2: That the City of Pocatello hereby certifies a tax levy in an amount not to exceed \$35,865,971 on the full market value of all taxable property within the corporate limits of the City of Pocatello, Bannock County, Idaho and Power County, Idaho to provide revenue for the following purposes:
