# **SWEEPING**

Street sweepers are currently performing their regular sweeping schedule.

Monday: Northend
Tuesday: East Side
Wednesday: Fairway
Thursday: West Side

#### **PATCHING**

The Street Operations crew will be patching potholes and curb lines throughout the City in preparation for upcoming pavement management projects. This may require intermittent lane closures and possible temporary road closures as work is performed. Motorists are advised to use caution and expect delays in these areas.

# **PAVEMENT MARKINGS**

Beginning Monday, June 24, 2024, the Traffic Operations crew will begin repainting crosswalks and arrows starting at school locations and continuing throughout the City, weather permitting. The work will continue for the remainder of the season. There will be intermittent lane closures while crews are painting. Drivers are advised to watch for traffic control to stay safe and avoid driving through fresh paint. Please expect delays while work is being performed.

# ANNUAL HYDRANT FLUSHING PROGRAM

Water Department will be conducting their annual hydrant flushing program beginning Monday, May 20, 2024. If you see a crew flushing a hydrant on your street, we recommend you avoid running tap water or using the washing machine or dishwasher until flushing is completed. If you see hydrant-flushing crews working, please drive carefully and treat them like any other road construction crew.

WATER MAINLINE REPLACEMENT – WINGATE DR., TURACO AVE., FLAMING PL. AND FLAMINGO DR. Beginning Monday, July 1, 2024, crews from the Water Department will be replacing the water mainline on Wingate Dr., Turaco Ave., Flaming Pl. and Flaming Dr. The project will start at the intersection of Sandpiper and Wingate, continuing down Wingate to Turaco Ave, connecting Wingate to Northgate via Turaco Ave, and connect at Wingate and Pole Line. The project will start again at Wingate and Flamingo Dr. to Flamingo Dr and Flamingo Pl. then complete at Flamingo Dr. and Tanager Dr. Crews will work between the hours of 6:30 a.m. to approximately 5:00 p.m. Monday through Thursday. During the project, access to the construction area will be restricted and sections of the street will be completely closed while workers are digging. Every effort will be made to provide local access to the area when possible. Parking will also be restricted in the construction zone and residents are asked to park all vehicles away from the area during working hours. At the close of each day, access will be restored to all properties. Please be advised to use caution.

# I-86/I-15 SYSTEM INTERCHANGE PROJECT

Beginning Wednesday, August 10, 2022, Chubbuck Rd. will be closed between Pleasant View Dr. and Fairgrounds Rd. as part of the I-86/I-15 System Interchange project. This portion of Chubbuck Rd. will remain closed until Fall 2024 for roadway and bridge construction activities. A detour directing traffic around the closure via New Day Parkway/Northgate Parkway is in operation. # **CANNON BUILDERS – CENTER STREET UNDERPASS**

The Center Street underpass is scheduled to undergo structural work on the ingress/egress retaining walls from April to late October 2024. As a result, the underpass will be closed during this period. We request you to plan your travel and use alternate routes while the construction is in progress. The contractor will make efforts to keep a pedestrian route open. Please note that it will be an active construction zone, so exercise caution while entering the area.

# SUNROC CORPORATION – HAWTHORNE RD. AND W. QUINN RD.

Sunroc Corporation is installing signal poles at the intersection of Hawthorne Road and W. Quinn Road. There will be intermittent lane closures. Motorists are advised to use caution and anticipate potential delays in the area as the intersection is operating as a 4-way stop while the signal poles are being installed.

#### JAG ENTERPRISES & AMERIGO – HAWTHORNE RD. AND W. QUINN RD.

Beginning Thursday, June 27, 2024, through Thursday, July 11, 2024, JAG Enterprises and Amerigo will be taking an existing power pole line and putting it underground at the intersection of Hawthorne Road and W. Quinn Road. There will be temporary road closures. Motorists are advised to use caution and anticipate potential delays in the area as the intersection is operating as a 4-way stop.

#### IDAHO POWER COMPANY – COUNTRY CLUB DR.

Beginning Monday, July 8, 2024, through Friday, August 16, 2024 from 8 AM – 4 PM, Idaho Power Company will be upgrading their distribution feeder to current standands, which includes: Replacing crossarms, sparkles arresters, jumpers, and fuses on the overhead distribution poles. There will be intermittent lane closures in this area during the above-referenced times. Motorists are advised to use caution and expect delays in the area.

# **VOLTAGE POWER SOLUTIONS – W. QUINN RD.**

Beginning Thursday, July 11, 2024, through Friday, July 12, 2024, Voltage Power Solutions will be working on 1730 W. Quinn Rd. Crews will be locating underground utilities for Idaho Power Company. There will be intermittent lane closures in this area during the above-referenced times. Motorists are advised to use caution and expect delays in the area.

# MORRIS EXCAVATION – N. PHILBIN RD.

Beginning Thursday, July 11, 2024, through Friday, July 12, 2024, Morris Excavation will be working on N. Philbin Rd. from the intersection of Kinghorn Rd. and Brock Dr. Crews will be removing existing patches and replacing them with new asphalt. There will be temporary road closures in this area during the above-referenced times. Motorists are advised to use caution and expect delays in the area.
