MICRO SEAL

Valley Slurry Seal will begin micro sealing the streets listed in the schedule below. Flaggers will be present to direct traffic and lanes/roads will be closed as work is performed, with restricted access to residents. There will be no parking allowed on these streets from 7 AM – 6 PM or until work is completed. Vehicles parked on the street will be towed to the nearest side street. Residents are asked to clear the road in front of their house of any obstructions (i.e. basketball hoops, garbage containers, etc.) The schedule may be changed due to unforeseen circumstances such as weather or breakdowns. Motorists are advised to use alternate routes and expect delays in the work areas.

PATCHING

The Street Operations crew will be patching potholes and curb lines throughout the City in preparation for upcoming pavement management projects. This may require intermittent lane closures and possible temporary road closures as work is performed. Motorists are advised to use caution and expect delays in these areas.

PAVEMENT MARKINGS

Beginning Monday, June 24, 2024, the Traffic Operations crew will begin repainting crosswalks and arrows starting at school locations and continuing throughout the City, weather permitting. The work will continue for the remainder of the season. There will be intermittent lane closures while crews are painting. Drivers are advised to watch for traffic control to stay safe and avoid driving through fresh paint. Please expect delays while work is being performed.

➡ WATER DEPARTMENT

WATER MAINLINE REPLACEMENT – WINGATE DR., TURACO AVE., FLAMINGO PL. AND FLAMINGO DR.

Beginning Monday, July 1, 2024, crews from the Water Department will be replacing the water mainline on Wingate Dr., Turaco Ave., Flamingo Pl. and Flamingo Dr. The project will start at the intersection of Sandpiper and Wingate, continuing down Wingate to Turaco Ave, connecting Wingate to Northgate via Turaco Ave, and connect at Wingate and Pole Line. The project will start again at Wingate and Flamingo Dr. to Flamingo Dr and Flamingo Pl. then complete at Flamingo Dr. and Tanager Dr. Crews will work between the hours of 6:30 a.m. to approximately 5:00 p.m. Monday through Thursday. During the project, access to the construction area will be restricted and sections of the street will be completely closed while workers are digging. Every effort will be made to provide local access to the area when possible. Parking will also be restricted in the construction zone and residents are asked to park all vehicles away from the area during working hours. At the close of each day, access will be restored to all properties. Please be advised to use caution.

➡ WATER POLLUTION CONTROL

SEWER MAINLINE MAINTENANCE

Crews will be jetting and cleaning sewer mainlines throughout the City. Motorists may experience delays or lane closures while crews are performing the work. Please be advised to use caution.

➡ IDAHO TRANSPORTATION DEPARTMENT

I-86/I-15 SYSTEM INTERCHANGE PROJECT

Beginning Wednesday, August 10, 2022, Chubbuck Rd. will be closed between Pleasant View Dr. and Fairgrounds Rd. as part of the I-86/I-15 System Interchange project. This portion of Chubbuck Rd. will remain closed until Fall 2024 for roadway and bridge construction activities. A detour directing traffic around the closure via New Day Parkway/Northgate Parkway is in operation. NEW NATURAL GAS LINE INSTALLATION

Beginning Tuesday, July 23 through Friday, July 26, 2024, Intermountain Gas will be installing a new natural gas service line to serve 1357 E. Clark St. There will be temporary road closures on E. Clark St. from N. 12th Ave. to N. 13th Ave. Motorists are advised to use caution and expect delays in the area.

➡ **CONTRACTORS**

CANNON BUILDERS – CENTER STREET UNDERPASS

The Center Street underpass is scheduled to undergo structural work on the ingress/egress retaining walls from April to late October 2024. As a result, the underpass will be closed during this period. We request you to plan your travel and use alternate routes while the construction is in progress. The contractor will make efforts to keep a pedestrian route open. Please note that it will be an active construction zone, so exercise caution while entering the area.

SUNROC CORPORATION – HAWTHORNE RD. AND W. QUINN RD.

Sunroc Corporation is installing signal poles at the intersection of Hawthorne Road and W. Quinn Road. There will be intermittent lane closures. Motorists are advised to use caution and anticipate potential delays in the area as the intersection is operating as a 4-way stop while the signal poles are being installed.

MICHELS PACIFIC ENERGY – COUNTRY CLUB DR.

Beginning Monday, July 8, 2024, through Friday, August 16, 2024, from 8 AM – 4 PM, crew members will be upgrading the Pocatello 13 distribution feeder to current IPC standards, which includes: Replacing cross-arms, sparkless arresters, jumpers, and fuses on the overhead distribution poles. There will be intermittent lane closures in this area during the above-referenced times. Motorists are advised to use caution and expect delays in the area.

D-CO CONCRETE – S 5TH AVE.

Beginning Monday, July 8, 2024, through Thursday, August 8, 2024, crew members will be installing ADA ramps at the S. 5th Ave. and Clark St. intersection. There will be intermittent lane closures in this area during the above-referenced times. Motorists are advised to use caution and expect delays in the area.

21ST CENTURY REMODELING – N. ARTHUR AVE.

On Monday, July 22, 2024, 21st Century Remodeling will be excavating the roadway to connect to the City main water line on 442 N. Arthur Ave. There will be temporary road closures on N. Arthur Ave. from W. Wyeth St. to W. Fremont St. Motorists are advised to use caution and expect delays in the area.
