➡ STREET OPERATIONS DEPARTMENT

SWEEPING

Street sweepers are currently performing their regular sweeping schedule.

PATCHING

The Street Operations crew will be actively patching potholes and curb lines throughout the City, the work may result in possible lane closures and delays. Motorists are advised to proceed with caution.

MILLING AND PAVING

From Monday, October 14 to Thursday, October 17, 2024, the Street Operations crew will be milling and paving the following locations from 7 AM until completed. The schedule may change due to unforeseen circumstances such as weather or equipment availability. There will be road closures while work is performed. Please use adjacent roads for travel. Be advised to use caution and expect delays in the area.

- **Wingate Dr.** (From *Pole Line Rd.* to *Sandpiper Dr.*)
- **Turaco Ave.** (From *Wingate Dr.* to *Northgate Dr.*)
- **Flamingo Dr.** (From *Wingate Dr.* to *Tanager Dr.*)
- **Flamingo Pl.** (From *Flamingo Dr.* to *EOP*)

PAVEMENT MARKING

Traffic Operations Department crew is repainting crosswalks, arrows, and lane markings throughout the City, starting near schools. Intermittent lane closures will be in effect. Drivers should follow traffic control signs, avoid fresh paint, and expect delays during this painting season.

WATER MAINLINE REPLACEMENT – WINGATE DR., TURACO AVE., FLAMINGO PL. AND FLAMINGO DR.

Starting July 1, 2024, the Water Department will replace water mainlines on Wingate Dr., Turaco Ave., Flamingo Pl., and Flamingo Dr. Work hours are 6:30 AM – 5 PM, Monday to Thursday. Street closures and restricted parking will be implemented during construction. Efforts will be made to provide local access and access to properties will be restored daily. Please be advised to use caution.

SEWER MAINLINE MAINTENANCE

Starting October 14, 2024, for approximately two weeks or until the project is completed, WPC will replace a manhole on the 1200 block of E. Clark St. between N. 11th & N. 12th Ave. JAG Enterprises will perform the work and will require bypassing the sanitary sewer mainline during the project. This may impact E. Center St. and E. Lander St. as well. Parking will be restricted in the construction zone. Motorists are advised to expect delays as traffic will be limited to one lane or possibly detoured during the project completion.

Additionally, WPC crews will be jetting and cleaning sewer mainlines throughout the City. Motorists may experience delays or lane closures while crews are performing the work. Please be advised to use caution.

➔ **IDAHO TRANSPORTATION DEPARTMENT**

I-86/I-15 SYSTEM INTERCHANGE PROJECT

Chubbuck Rd. will be closed between Pleasant View Dr. and Fairgrounds Rd. beginning August 10, 2022, until Fall 2024 for construction related to the I-86/I-15 System Interchange project. ➔ **CONTRACTORS**

CM COMPANY, INC. – N 6TH AVE.

From July 29 to November 30, 2024, CM Company, Inc. will be working on the construction of roadway and sidewalk improvement on N 6th Ave. There will be road closures between E. Clark St and E. Center. Please use adjacent roads for travel. Motorists should be cautious and anticipate delays in the area.

STARR CORPORATION – E. HUMBOLT ST.

From September 16 to October 16, 2024, crew members will be installing sidewalks, curbs, gutters, bus stops, and landscaping on E. Humbolt St. from S. 5th Ave. to the corner near the Child Care—Early Learning Center at ISU, causing intermittent lane closures. Motorists should be cautious and anticipate delays in the area.

ENGINEERED STRUCTURES, INC. (ESI) – MARTIN LUTHER KING JR WAY.

From July 30 to October 31, 2024, ESI will bore power communication lines from the ISU campus to Eli Oboler Library. There will be intermittent lane closure on Martin Luther King Jr. Way. Motorists should be cautious and anticipate delays in the area.

JAG ENTERPRISES – E. CLARK ST.

From October 13 to October 28, 2024, crew members will be working on a sewer emergency on E. Clark St. There will be intermittent lane closures on E. Clark St. between N. 11th Ave. and N. 13th Ave. Motorists should be cautious and anticipate delays in the area.

BOTT – WILLOW AVE.

From October 16 to October 17, 2024, crew members will remove and replace the asphalt to address a sewer line repair on Willow Ave. leading to temporary road closures from W. Sublette St. to W. Hayden St. Please use adjacent roads for travel. Motorists should be cautious and anticipate delays in the area.

VOLTAGE POWER SOLUTIONS – MT. MCGUIRE DR.

Beginning Monday, October 14, through Friday, October 18, 2024, crew members will be trenching across Mt. McGuire Dr. for Idaho Power between Center St. and Silverwood Pl. There will be intermittent lane closures. Motorists are advised to use caution and expect delays in the area.

VOLTAGE POWER SOLUTIONS – HOSPITAL WY. & BIRDIE THOMPSON DR.

From August 19 to October 18, 2024, Voltage Power Solutions crew members will be potholing to locate any underground utilities on Hospital Wy. and Birdie Thompson Dr. There will be intermittent lane closures. Motorists should exercise caution and anticipate delays in the area.

PORTNEUF VALLEY FARMERS MARKET

The "Portneuf Valley Farmers Market" takes place every Saturday from May 4 to October 26, 2024, at Lookout Point in Historic Downtown Pocatello. The event is in the 100 block of S. Garfield Ave in front of the Marshall Public Library, causing road closures and potential delays.
