AGREEMENT WAIVER and RELEASE ATHLETIC LEAGUE

I understand that the sport listed on the reverse side of this form may be of a hazardous nature and/or include physical and/or strenuous exercise or activity; that serious accidents occasionally occur during the above sports activity; and that participants in this sports activity occasionally sustain mortal or personal injuries and/or property damages as a consequence thereof. Knowing the risks involved, nevertheless, I have voluntarily applied to participate in said activity and I hereby agree to assume for my minor child any and all risks of injury or death and to release or hold harmless the City of Pocatello (its officers, employees, and agents) who might otherwise be liable to me or my minor child.

I further agree to indemnify and to hold the City of Pocatello (its officers, employees, and agents) and all entities (and their officers, employees and agents) that provide facilities for the sport listed on the reverse side of this form stated program, free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of any injury and/or property damage that I or my minor child may sustain while my minor child is participating in said activity.

I understand that I am responsible to provide my own health and accident insurance in the case that my minor child is injured while participating in the sport listed on the reverse side of this form.
