- Temporary Certification (expires at next ESC class/6 months; no renewal)

**Submit the completed form to the City of Pocatello, along with the applicable fee.**

Your class instructor will notify the City of Pocatello within three (3) working days of who passed the exam. If your application form and check arrive prior to this, the City will hold both until they are notified that you have/have not passed. If you did NOT pass the exam, your check will not be cashed and the City will contact you by phone.
